It may result in a quick resolution of the dispute and have the benefit of taking into account many other factors beyond the mere legal "right" or "wrong".

The workshop introduces, in a highly interactive fashion, core concepts of mediation and negotiation on the basis of the Vis case. It starts with an economic evaluation of the case, explains how to prepare for a mediation and what to consider in order to conduct a fruitful negotiation. The objective of the workshop is to allow students to experience the process of mediation and thereby understand how this approach differs from litigation or arbitration.

The workshop gives the students the opportunity to interact with other students in role play sessions. The students will receive feedback on their performance. The active experience, combined with lectures that give guidance and insights on mediation and negotiation, shall assist students in improving the skills necessary to represent clients in negotiations and mediations.

In the course of the two days, there will be role plays. In each role play, the participants will be assigned to roles either as negotiator, as mediator or observer. Preferences for a certain role will be taken into consideration to the extent possible.
