The conference will ask how arbitration can continue to deliver justice and stability across Southeastern Europe amidst technological disruption and shifting regulatory frontiers.

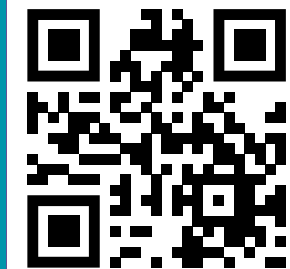
