#### Registration

The registration fee is EUR 190. For inhouse counsels, the reduced registration fee of EUR 130 applies. <u>Click here to register.</u>

To complete the registration, <u>two steps are required</u>, registration for the conference and a separate registration for the workshops and social events.

The registration can by cancelled without incurring a cancellation fee until 14 days prior to the CCC24. If the cancellation is received between 14 days to 7 days before the CCC24, the cancellation fee is 70% of the registration fee. If the cancellation is received 7 days or less before the CCC24, the cancellation fee is 90 % of the registration fee. In all cases, the registration must be made in writing. 

#### Travelling


