CCC24 Scholarships - Urgent call for applications

The DIS40 is proud to announce that our Platinum Sponsor **Freshfields Bruckhaus Deringer** is funding scholarships for CCC24 attendees who either work as inhouse counsel anywhere in the world or as legal professionals in the Global South Region*. Please see the application details below.

In collaboration with Freshfields Bruckhaus Deringer the DIS40 is offering a total of 20 Inhouse Counsel and 10 Global South Region scholarships.

Successful applicants will receive a scholarship of at least EUR 250 (Inhouse Counsel) or EUR 500 (Global South) to cover their registration fee, travel and/or accommodation costs.

Please note that you can also apply for the CCC24 Scholarships if you have already registered for the CCC24!

Inhouse Counsel Scholarship, if:

- you work as an inhouse counsel* anywhere around the world,
- you are 45 or younger,
- your employer does not cover the CCC24 registration fee or related travel and accommodation costs, and
- you have already registered/will register as a CCC24 participant.

Global South Region Scholarship, if:

- you work as a legal professional in the Global South Region*,
- you are 45 or younger,
- your employer would not cover the CCC24 registration fee or related costs for travel and accommodation, and
- you have already registered/will register as a CCC24 participant.

How to apply and deadline:

If you meet the above criteria, send your application by email to <u>DIS40@disarb.org</u> **on or before 1 May 2024**.

Make sure to <u>express your motivation</u> and in addition provide and <u>confirm</u> that:

- You meet the criteria described in the table above;
- You will attend the CCC24;
- Age, country of residence, employer.

^{*} Please note: Only (1) inhouse counsel, or (2) legal professionals working in the Global South Region can apply for a scholarships. The Global South Region means: Africa, Latin America, Caribbeans, Asia (without Israel), Japan, Republic of Korea, and Oceania (excluding Australia and New Zealand), Source <u>UNCTAD</u>.

Please note:

DIS40 will decide on all applications by 3 May 2024 and notify successful applicants immediately, including the decision on the budget. The scholarships will be paid out to all successful applicants who have attended the CCC24 shortly after the CCC24. No proof of expenses is required for payment of a scholarship.

DIS40 may, depending on the number of applications, extend the budget of EUR 250 (Inhouse Counsel) / EUR 500 (Global South) for successful applicants. The scholarship will not exceed the estimated travel costs (confirmed by a booking platform's itinerary with 3*/4* hotel in Frankfurt/Region, flight in economy class, train ticket in economy class [Deutsche Bahn, 2. Klasse]).

If the number of applications exceeds the number of scholarships available, a random draw will determine the successful applicants.

Information on CCC24 Registration and Accommodation

Registration

The registration fee is EUR 190. For inhouse counsels, the reduced registration fee of EUR 130 applies. <u>Click here to register.</u>

The registration can by cancelled without incurring a cancellation fee until 14 days prior to the CCC24. If the cancellation is received between 14 days to 7 days before the CCC24, the cancellation fee is 70% of the registration fee. If the cancellation is received 7 days or less before the CCC24, the cancellation fee is 90 % of the registration fee. In all cases, the registration must be made in writing.
