Louis B. Kimmelman is an independent arbitrator based in New York and is Chair of the New York International Arbitration Center. He retired as a partner of Sidley Austin LLP in December 2020, after having been a co-leader of Sidley's global international arbitration practice. As an arbitration practitioner, he acted as lead counsel in complex commercial and investment treaty disputes under all the major international arbitration rules and served as an arbitrator in international and domestic disputes. Mr. Kimmelman also represented parties involved in litigation in aid of the arbitration process, such as compelling parties to arbitrate and enforcing arbitration awards. He is an adjunct professor of law at Brooklyn Law School and Georgetown University Law Center, where he teaches International Commercial Arbitration, and also at Washington School of Law of American University, where he teaches a course on arbitration under the ICC Rules of Arbitration. He is an adviser to the American Law Institute project on the Restatement of the U.S. Law of International Commercial and Investor-State Arbitration and is Co-Chair of the annual Fordham Conference on International Arbitration and Mediation. Mr. Kimmelman received his B.A. degree from Yale College and his J.D. degree from Yale Law School and clerked for the Honorable Leonard I. Garth of the U.S. Court of Appeals for the Third Circuit.

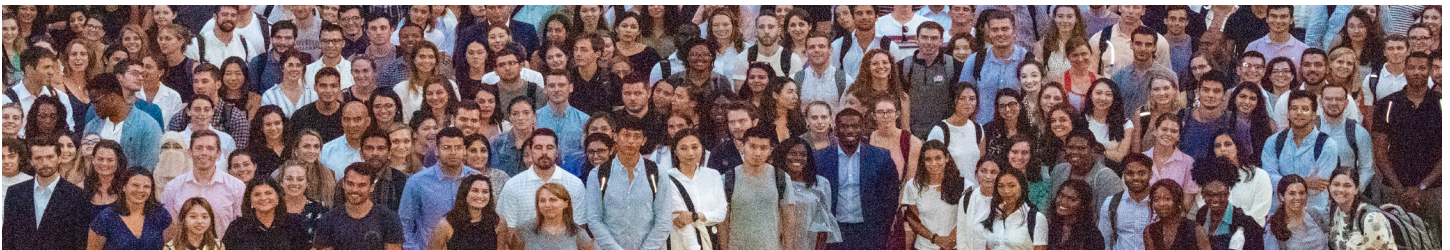

Ms. Sussman sits on the Board of the American Arbitration Association, serves as Chair of the New York International Arbitration Center, is the former chair of the AAA-ICDR Foundation, as a member of the consultative group for the American Law Institute's Restatement (Third) of the US law of International Arbitration and as Co-Editor-in-Chief of the *New York Dispute Resolution Lawyer*.
